PRESIDENT'S REPORT

2012 was the Squam Lakes Association's first year under the leadership of our new Executive Director, EB James, a year of amazing transformation.

We introduced a new overall Association strategy, Squam Watershed Wellness; a lake is only as clean as the land and streams surrounding it. A healthy lake, healthy land and healthy communities make for a healthy watershed.

We established our new Squam Conservation Intern program designed to train future environmental leaders. We offer this opportunity to college students studying environmental sciences. We had 8 openings for which we had 88 applicants from 20 states. These 8 interns work as Lake Hosts, educating boaters at launch sites about milfoil and other aquatic invasive, Campsite Caretakers, divers to remove milfoil, and do 80% of our trail maintenance. One graduate of last year's program is now employed as a summer biologist with the Loon Preservation Society

We introduced the Squam Ranger program to offer some competitive fun and encourage use of the entire SLA trail network. Almost 100 Rangers are hiking the 26 trails. 20 of the rangers have completed the challenge and received their Squam Ranger hats, patches and "Charter" member certificates. Take the challenge, join and have fun!

We extended our outreach to the local community with neighborhood networking and established mutually beneficial partnerships with local businesses. We've renewed our collaboration with PSU's Center for the Environment and are working on several joint projects.

We hired a part-time Volunteer Coordinator to reinvigorate our Volunteer program, our PR and our e-newsletter.

We shored up the Association's infrastructure: updating computers and software, full utilization of our membership software and a new website that allows staff to keep programs and calendars current and allows members to enter application information directly. Though not visible, these changes have given the staff better tools to work with and save them valuable time.

These changes all have been designed to help our Association better fulfill its mission and keep you, our membership, engaged in that effort. I love Squam!

EXECUTIVE DIRECTOR'S REPORT

2012 was an exciting year. The core of the organization remains as it has always been, an institution dedicated to conserving the natural beauty, peaceful character, and resources of the lake and watershed: Watershed Wellness. The primary components remain likewise unchanged; our drive for conservation; ethical and sensitive peaceful nature recreation; and education for all generations of residents and visitors to Squam. Within those deeply held convictions and program areas we had a lot change. Change in how we operate programs, change in systems, even change in the length of our active programming calendar.

“Work With” is a phrase I like. The SLA, in 2012, worked with PSU, NH Lakes, DES, F&G, LPC, SLCS, SLNSC, NE Adaptive, Heritage group, ELP to further our mission. Our partnerships were strong in 2012 and have been growing in 2013. We see this in the renewed vigor and scientific accuracy we are bringing to the milfoil program. We see this in our work on loons and lead and loon chick protection with the LPC and the Shoreland Protection Act passage with NH Lakes. We see this with recreation study recently completed by PSU Grad Student Andrew Viellieux with the PSU CFES. To cover all the efforts in this short space would be difficult, far easier to reference our recently produced Watershed Assessment report where you can see the collaboration first hand in the studies and information gathered around and in the Squam Lakes over the past years.

This report I reference is one of the new things coming out of 2012. It is an assessment of the watershed and lake. A look at how healthy this wonderful area is, a roadmap to how healthy we want it to be and what steps we need to take to get there, and finally an assessment of this organization and our work towards the mission.

We started an exceptional internship in 2012, the Squam Conservation Internship. This experience trains the next generation of leaders for an effective and successful career in conservation leadership. It provides college aged individuals with the knowledge, skills, abilities, and certifications for them to take the next step into professional careers. One of our interns from 2012 was hired this year by the LPC as a field biologist. In 2013 this competitive program is off to a great start with 8 interns, 5 of whom have deep and long lasting relationships with the lakes region and the Squam lakes.

Our changes are not without challenges. New systems, web pages, camp registration, databases, have steep learning curves. Every day we use them more effectively and discover things we have overlooked. We are bringing ever increasing professionalism to the way we operate. We appreciate the feedback of our members as we refine our communications, information flow, and connections to the greater Squam Lakes community.

TREASURER'S REPORT

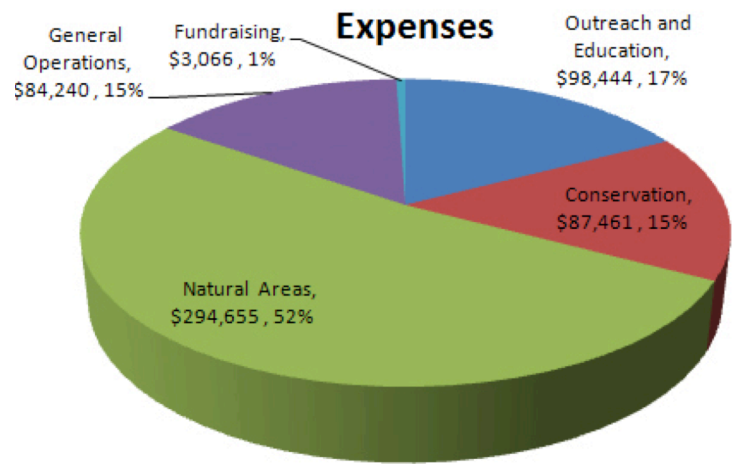
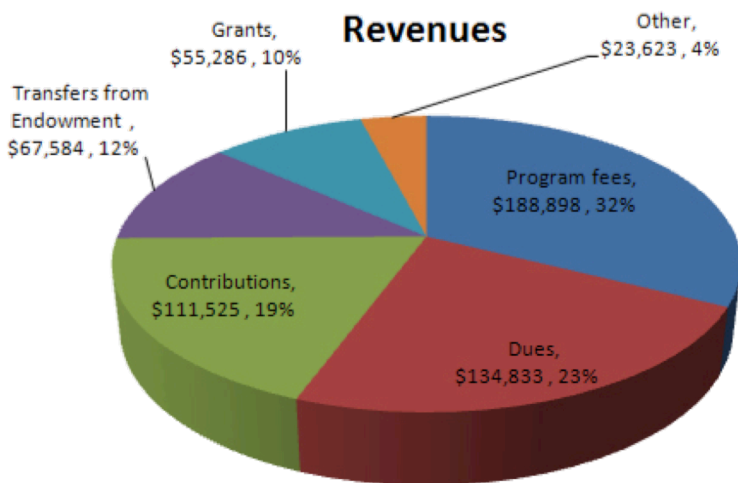
For the fiscal year ended December 31, 2012, net revenues from operations totaled \$13,882. Compared to the prior year, total operating revenues increased approximately 5 percent, while total operating expenses were relatively flat. Many initiatives are in place to continue to rationalize our expense base and efficiencies, while continuing to expand our sources of revenues and pursue the organization's mission.

The SLA's net assets at December 31, 2012 were \$6,98,538, an increase of 3.4 percent over the prior fiscal year end. Included in our net assets are highly liquid and marketable investment securities of \$2,503,876 (an increase of 12 percent from the prior year); which are managed so as to provide recurring income for the operations and projects of the organization, while maintaining a risk profile that minimizes the risk of the loss of principal. Our investment portfolio is comprised primarily of public equity and fixed income securities and mutual funds. All of our investments have public valuations readily available, and are stated at fair market value.

Financial statements are audited by Rowley & Associates, P.C. using generally accepted accounting principles for non-profit organizations. I am pleased to report that the SLA has received a clean opinion from our auditors. The SLA audited financial statements and footnotes are available on our website.

REPORT OF THE DEVELOPMENT COMMITTEE

The Development Committee holds monthly conference calls on the 3rd Wednesday of each month to review progress made on the defined objectives of the committee.

Donor Relations

We held our first Membership Reception August 14th, 2012 in Center Sandwich at which EB met members and talked about the SLA vision and plans. We will hold additional receptions in different parts of the Squam Watershed area.

The staff has an enhanced computer system which allows them to upgrade the membership/donor information in the data base so that it is now more complete and useful. In the future we can recognize donors support by level of support and length of membership. We will also increase visits and other contact with major donors to express our appreciation to them and to keep them informed about activities at SLA.

Planned Giving Program

We have taken the first step in this area by mentioning in recent Loon Flyers that we are initiating a Planned Giving Program. By learning who has included SLA in their estate plans, we can thank them for their generosity. We learned of one member who has SLA in his estate plan and expect there are others who we still need to identify. We will continue to mention this initiative in written and other communications with our membership and plan to formalize the program. This information will also be helpful in financial planning for SLA.

Corporate and Foundation Support

EB and the staff prepared proposals to a larger group of funders than in previous years. SLA's programs and vision are of interest not only to local funders but also to those who support our kind of activities on a national basis. At the end of the 2012 calendar year, SLA had received \$55,286 compared to the prior year's \$42,303.

Annual Fund Support

As of the end of the calendar year, SLA had received a total of \$227,224 from 1,127 donors. These figures do not include special projects and restricted funding. Board members wrote notes on letters and thank you calls were made and/or notes were sent to many of the donors to express our thanks and appreciation for their support. We will continue this program of calls and visits for major donors.

REPORT OF THE CONSERVATION COMMITTEE

In 2012, the Conservation Committee focused the following areas:

Updates of the Trail Guide and Lake Map: Work began this year on updating these core SLA publications. A group of volunteers is working with staff on changes to ensure that our publications are accurate and up to date.

Trail Protection Task Force: Conservation Committee members are working with the Squam Lakes Conservation Society on protecting the SLA's trails. Many landowners generously allow the public to use their land and our trails on an informal basis. With the SLCS, we are working on identifying landowners and creating appropriate documentation for continued protection of this valuable resource.

Milfoil Removal: Since 2000, when variable milfoil (*Myriophyllum heterophyllum*) was discovered in the Squam Lakes, the SLA has tirelessly worked to keep this submerged invasive aquatic plant controlled. In 2012 the SLA removed more than 3,500 gallons of variable milfoil from the Squam Lakes. This record breaking year was a result of our successful Squam Conservation Internship Program and our milfoil control boat, Millie, which houses a Diver Assisted Suction Harvester (designed by SLA Director of Recreation Brett Durham).

Lake Use and Management Study: The Center for the Environment at Plymouth State University is working on developing a Lake Recreation Management Decision System (LRMDS) for the Squam Lakes. This project builds on a previous study, the Squam Water Recreational Opportunity Spectrum (WROS) from UNH which assessed recreational zones on the lake. The Squam LRMDS considers additional dimensions, gathers input from stakeholders, and establishes recreational zones and key indicator conditions to be monitored in these areas. If changes in these conditions exceed the defined standards for the zones, the LRMDS creates a set of management actions that can be presented to stakeholders to choose from to address the changed conditions. By establishing zones with public input, defining standards, and presenting management options, the LRMDS will help with decision making to ensure the health of the Squam Lakes.

Report Card Task Force: This new group was formed in the summer of 2012. The group has been working with staff on developing a short report card summarizing existing water quality, milfoil, and boat census data. It will support a larger, longer term effort on assessing the watershed's wellness.

We thank Sarah Thorne, previous Conservation Committee Chair, for all her work and help with the Conservation Committee.

REPORT OF THE EDUCATION & OUTREACH COMMITTEE

Summer Program

We continue to adapt and improve our range of programs thanks to feedback from our participants and volunteers. We offered a week of Family Camp over the Fourth of July week. The Junior Squam Lakes Association (JSLA) day camp saw some changes in hiking destinations, and extended adventure style camping experiences for our Expedition age (7th, 8th, 9th grades). Our Community Youth Sailing program now includes an advanced sailing component and we added an adult sailing program in 2013. This program offers both classroom instruction and time on the lake.

We enrolled a total of 225 youth in our summer programming. JSLA's enrollment increased over last year. Our new Leader in Training Program was full in 2012 with 18 youth participating.

Staff

Our summer staff for 2012 was outstanding; many had great connections to the lake along with a variety of hard and soft skills that made for an exceptional summer. We are grateful for the work of our volunteers, including board committee members Jane Beck, John Fernandes, and Carolyn Tolles, as well as Tom Beal and Bev LaFoley, who joined the committee to lend their years of experience and perspective to our planning.

Outreach

The Squam Speaker Series was well attended in the off season. Participants in our boat building course with Bill Thomas built five Fox Double Paddle Canoes in the barn. We are offering this program again in 2013.

We offered an overnight "Family" event on Moon Island with Holderness Recreation Department. Dan Kemp, Antioch graduate student and Squam resident, worked on the Tudor Richards Ecology Trail – now called the Moon Island Ecology Trail – and completed the installation of the trail signs on the island. We offered fly tying courses and a wood duck box building program.

We piloted a retreat program on Bowman Island. We worked with the Environmental Leadership program to host 12 conservation professionals from across the country who learned about system thinking in context with mission delivery. We received a grant from the NH Charitable foundation to expand this program in 2013 and will be hosting more retreats this fall.

We look forward to another successful year of education and outreach programming, fueled by the excellent ideas and volunteer time of our members and participants.
